Submission on the Commerce Commission's specified points of interconnection consultation paper

26 November 2019



OVERVIEW AND SUMMARY OF ISSUES

Introduction

- This submission responds to the Commerce Commission's (**Commission**) Specified Points of Interconnection Consultation Paper of 12 November 2019 (**Paper**). We welcome this opportunity given the importance of the specified points of interconnection to the operation and regulation of our fibre services.
- We understand the Commission is using its power in section 231 of the Telecommunications Act (**Act**) to codify all points of interconnection that apply under the UFB initiative, and specify the UFB initiative areas to which they relate.
- 3 Section 231 has both a regulatory purpose and an operational purpose. From a regulatory perspective, the specified points of interconnection delineate the boundary of the regulated fibre fixed line access services and define specified fibre areas. Operationally, retail service providers (**RSPs**) need a unified list of the available points of interconnection, which function as handover points. The list of prescribed points of interconnection needs to continue to meet both these requirements going forward. We have set out our position on the key issues arising from the Commission's prescription of points of interconnection under section 231 in light of these purposes.
- The Act requires the Commission to prescribe points of interconnection based on those that apply as at 31 December 2019. This should be a straightforward task that involves understanding which points of interconnection are provided for under our agreements with CIP, any that exist for fibre services outside of UFB areas and reflected in the agreements currently in place between Chorus and our customers. Our agreements currently provide for points of interconnection for both layer 1 and layer 2 services. The Act does not give the Commission discretion on which points of interconnection under the UFB initiative to apply for its first notice. Accordingly, the Commission's notice must include both layer 1 and layer 2 points of interconnection. If they are not all included, that raises uncertainty as to the regulatory implications as layer 1 handover points are key to defining our layer 1 services, for example, our direct fibre access service (**DFAS**).
- The Commission also has the power to include additional points of interconnection beyond the UFB initiative. The provision of this power recognises that there may be good reasons to include additional points of interconnection, and accordingly to ensure there is a mechanism, as exists today, that enables points of interconnection to continue to evolve. Any departure from the existing flexibility could have unintended consequences for network developments and resilience.

Preliminary Interpretation Issue

When describing points of interconnection, precision is important. In this submission, we use references to "POI" and "point of interconnection" consistent with the way they are defined in the UFB initiative contract (**NIPA**) between Chorus and Crown Infrastructure Partners (**CIP**):



- 6.1 "points of interconnection" refer to points where an access seeker's network can connect to Chorus' fibre network, including layer 1 and layer 2 handover points; and
- 6.2 "POI" refers to the layer 2 points of interconnection that are listed in Annexure 4 of Schedule 5 of the NIPA to serve a Network Stage.
- In other words, POI is a subset of points of interconnection, not an abbreviation for the same thing.¹ This is important as it impacts the scope of the Commission's powers under section 231 of the Act. Functionally, both the POIs for our layer 2 services, and the points of interconnection for our layer 1 services, allow for RSPs to "interconnect" with our network. The RSP may pick up traffic at that particular Central Office (**CO**) itself or use our backhaul, third party backhaul, or the RSP may provide its own backhaul to transport the access traffic to another CO.

Key Issues

- The key issues and points of difference and agreement with the Commission's position in the Paper are:
 - 8.1 We disagree with the Commission's position that it should not specify layer 1 points of interconnection. The NIPA is the starting point for the definition of points of interconnection and the NIPA recognises that points of interconnection refers to both layer 2 points of interconnection (known as POIs) and layer 1 points of interconnection. This also reflects the actual layer 1 and layer 2 network architecture. Accordingly both layer 1 and layer 2 points of interconnection should be specified under section 231.
 - 8.2 We agree with the Commission's starting point of ensuring there is at least one specified point of interconnection for all end-users within each candidate area. However, it is inaccurate to state that there is a single point of interconnection per candidate area, either as a matter of contract or operational reality. The NIPA² provides for a *minimum* of one point of interconnection per candidate areas but specifically requires more than one point of interconnection in some cases.
 - 8.3 We also agree with using the Operations Manuals under the NIPA to identify these initial specified points of interconnection, but (in addition to the above point that there is more than one point of interconnection in some candidate areas) there have been additional points of interconnection added in several areas for various reasons. As a result the Commission's proposed list of specified points of interconnection as at 31 December 2019 does not reflect all operational points of interconnection.



Accordingly, all POIs (layer 2 points of interconnection) are also layer 1 points of interconnection; but not all layer 1 points of interconnection are POIs (layer 2 points of interconnection).

- 8.4 We agree with the format and (generally) the content of the Commission's list of points of interconnection, although we have identified some errors. There is a reference in the Paper to specifying the geographic area covered by each specified POI, but ultimately this information would be difficult to include in a table like the one proposed, and kept up to date as UFB2 is still being built. We think it is sufficient for the table to specify the location of the layer 2 POI it was created to service by referring to the UFB1 candidate area.
- 8.5 We agree with the Commission's proposal that the relevant physical address for each point of interconnection should only be provided on a confidential basis.
- 8.6 We have identified some errors with the Commission's proposed table of "Chorus POIs" and attach an updated list, including additional points of interconnection that are currently operational. We also attach a confidential table with planned or in progress layer 2 points of interconnection, and provide proposed tables specifying points of interconnection for layer 1 (see Appendices C and D).
- 8.7 It is important that the Commission's power under section 231 is exercised in such a way as to accommodate necessary operational changes to the list of specified points of interconnection. The process for changing points of interconnection is currently managed through appropriate industry consultation and associated change provisions (as required by the Wholesale Services Agreement³ (WSA)), followed by recommendations for changes to CIP without additional consultation. If CIP approves the changes, they take effect with specified notice periods. As the Commission becomes responsible for changes to the list of specified points of connection under section 231, we expect that the Commission will operate in a similar manner to CIP. In particular, it is critical that we can continue to make appropriate network configuration changes, for example, the removal or addition of points of interconnection to deal with capacity constraints at existing points of interconnection, meet demand requirements and ensure network resilience).
- 9 We address each of these issues below and respond to the Commission's consultation questions in Appendix A.

LAYER 1/LAYER 2 POINTS OF INTERCONNECTION

10 We reiterate the point made in our submission on Fibre Emerging Views⁴ that the Commission should prescribe, under section 231, the specified points of interconnection for both layer 1 and layer 2 services as the fibre handover points are different for each layer, and as recognised in the NIPA today. The identification of different points of interconnection for layer 1 and layer 2 is important because these points determine the scope of the regulated service for each of layer 1 and layer 2 (as the Act regulates particular fibre access services, not the network itself).

- 11 As we understand, the Commission's position that it should not specify layer 1 points of interconnection is based on its:
 - 11.1 Interpretation of the NIPA;
 - 11.2 Assumption, consistent with an assumption made by the Select Committee in commenting on the Telecommunications (New Regulatory Framework)

 Amendment Bill, that there is only one point of interconnection per candidate area; and
 - 11.3 View that multiple points of interconnection per end-user is inconsistent with taking a "single network" approach to the definition of "fibre network".
- However, both the NIPA and a correct understanding of our network architecture support multiple points of interconnection, including at layer 1 and layer 2, being specified. This approach is not inconsistent with a "single fibre network" approach to the Act.

Points of interconnection under the NIPA

- The Commission is required in its first notice to prescribe points of interconnection based on the points of interconnection that apply under the UFB initiative, although it is not limited to only UFB points of interconnection.⁵ As the Act doesn't define "points of interconnection", the starting point should be how this term is used in the contracts governing the UFB initiative.
- 14 The definition of "points of interconnection" evolved between the NIPA for UFB1 and NIPA for UFB2. However, the current definition in the UFB2 NIPA clearly covers not just the points we colloquially refer to as "POIs" but also to the central office or other point of interconnection to the network. The UFB2 NIPA contains the relevant definitions:⁶
 - 14.1 "CO" as "the point at which an RSP will connect to the Dark Fibre Services";
 - 14.2 "POI" as "the Point of Interconnection ... identified in Annexure 4 of Schedule 5 of the POI used (or to be used) to serve a Network Stage"; and
 - 14.3 "Point of Interconnection" as "in respect of any dark fibre wholesale services, the CO or point of interconnection to the Network and, in respect of all other wholesale services, the point of interconnection to the Network".
- In the UFB1 NIPA, "points of interconnection" was not a defined term. However, Schedule 5 defined "Interconnection Point" in the same terms as the UFB2 contract defines "Point of Interconnection" and the change between the NIPA versions is consistent with the natural interpretation that 'interconnection point' and 'point of interconnection' are interchangeable. Furthermore, the WSA also uses the term

- "Interconnection Point" throughout, including in the change mechanism in clause 3.1 (which covers changes to points of interconnection).
- The Commission's characterisation of the points of interconnection it must prescribe under section 231 appears to be based primarily on the definition of "POI" in the NIPA for UFB1. In the Paper, the Commission uses the definition "POI" to refer to points of interconnection both in a general and specific sense, and has excluded layer 1 points of interconnection from the scope of its powers of prescription, on the basis that the layer 1 handover points are not referred to as "POIs" in the NIPAs.
- This is an incorrect characterisation because "POI" is a subset of "points of interconnection" as that term is used in the NIPA. References to "points of interconnection" are properly interpreted as referring to both CO handover points (i.e. layer 1 points of interconnection) as well as what we commonly refer to as POIs (i.e. layer 2 points of interconnection). Accordingly, the specified points of interconnection under section 231 should cover both layer 1 and layer 2 with separate lists acknowledging that each has different handover points.
- Despite conflating points of interconnection with "POI" in the NIPA, the Paper appears to recognise that layer 1 and layer 2 services have different handover points:⁷


The NIPAs consistently make a distinction between layer 2 handover points, which are called POIs, and layer 1 handover points, which are referred to as being located at a Central Office (which is not also a POI).

- This view is consistent with our submission except that a layer 1 handover point at a CO is not a "POI", which according to the NIPA definition means a layer 2 point of interconnection, but is nevertheless a "point of interconnection".
- The operational distinction and interaction between layer 1 and layer 2 points of interconnection is illustrated in the diagram below. The diagram depicts the Nelson candidate area and the layer 1 points of interconnection in each Exchange Service Area (**ESA**) serving the layer 1 access network and the layer 2 POI serving the whole candidate area.

Nelson UFB1 Candidate Area




- 21 In the Commission's draft input methodology decision paper, it also explained that:8
 - ... we do not consider that prescribing POIs at the layer 1 aggregation points on the network is consistent with the words of the Act. In our view, to specify POIs at different layers of a network is not consistent with the definition of a single 'fibre network' in s 5.
- The definition of "fibre network" in the Act9 does not specify that there must be a "single" fibre network.
- In any case, our approach is not inconsistent with a single fibre network. The definition of the "fibre network" is simply the "network structure" used to deliver telecommunications services over a fibre media connection between an end-user and a regulated fibre service provider's fibre handover point. This is capable of encompassing all fibre links between an end-user and the points of interconnection that serve that end-user. As we explain below, there may be (and are) multiple layer 2 points of interconnection for a given end-user. Accordingly, the definition of "fibre

- network" does not cast any light on the interpretation of points of interconnection in section 231.
- In addition, it is unclear how the Commission's approach would affect assets used to provide only layer 1 services. If the Commission is correct that a specified point of interconnection cannot include a layer 1 handover point, and the definition of "fibre network" includes only those assets between a layer 2 point of interconnection and the end-user, then this would theoretically mean that any layer 1 assets that do not form part of this connection would not be within the "fibre network". This cannot have been Parliament's intention to apply different treatment to layer 1 vs layer 2 assets depending on variances of network architecture.



- The figure above illustrates a typical urban case, with a DFAS handover at the serving CO (the layer 1 point of interconnect) and layer 2 services (e.g. Bitstream 2) handover at another CO specified as a layer 2 point of interconnection. Note that the fibre network between the two COs supports both FFLAS and non-FFLAS services a combination of commercial backhaul and copper services in this case. Both layer 1 and layer 2 services are bounded by a handover point (the blue dot) at a point of interconnection, at which Chorus and RSP networks interconnect.
- We welcome the opportunity to further engage with the Commission on a technical level to ensure a common understanding of these issues.

Identifying POIs

- Every candidate area has a POI (i.e. a layer 2 point of interconnection) but it is incorrect to proceed on the basis that there is a single POI for each candidate area.
- The Commission has started from the point that there is a "1:1 relationship" between POIs and a candidate area based on its reliance on a requirement in the UFB1 NIPA that "[all] layer 2 end-users within a Candidate Area must be accessible from a single POI".¹¹
- It also relied on the Select Committee's description of points of interconnection, which also appears to be based a similar reading of the clause in the UFB1 NIPA:¹²

POIs are the places where the retail service provider's network connects to the wholesale fibre provider's network. A feature of the Ultra-fast Broadband (UFB) architecture is a single POI per candidate area, driving competition and supporting open access.

The Commission's reading of the NIPA requirement (that all end-users within a candidate area must be accessible from a single POI, i.e. a layer 2 point of interconnection) appears to overlook the fact that it is a *minimum* requirement. It does not follow that there is only a single point of connection for an end-user; the requirement is that there must be *at least* one. Furthermore, in some cases more than one POI is *required* (i.e. if there are more than 50,000 connections). Clause 28 of Annexure 2 to Schedule 3 provides:

A sole POI in a Candidate Area must not support more than 50,000 Layer 2 End Users. Where a Candidate Area has more than 50,000 End Users, then at least two POIs must be supplied, and each POI must provide access to all End Users at the standard price and terms.

- Accordingly, the reference in the NIPA to a "single POI" does not mean that there must only be one POI in each candidate area, but simply means that each POI must enable access to all surrounding end-users to RSPs. This is implicitly acknowledged in the Commission's own draft list of POIs, which includes three POIs for Auckland.

It is a reasonable starting basis that there was a POI per candidate area; provided it is understood this was a minimum only.



- In addition, in practice additional POIs have been added since the original list in the Operations Manual, for various reasons, including capacity constraints at an existing POI. This has resulted in moving further away from the 1:1 relationship as increasingly a candidate area will have more than one point of interconnection. The potential for this is also acknowledged in the NIPA¹⁴ (which provides that it "does not preclude [Chorus] from offering additional optional POIs within a Candidate Area"). These "alternate POIs" enable us to facilitate growth where we cannot do so at an existing POI.
- A recent example of utilisation of this option was the addition of several POIs to manage network resilience and growth, where Rugby World Cup demand forecasts confirmed the need to bring forward the provisioning of these POIs to ensure sufficient handover capacity was available to serve the peak demands expected for the event. This resulted in adding POIs to existing candidate areas (including Wellington, Invercargill, Napier/Hastings and Hamilton). These resulting new POIs were practically agreed with RSPs (with CIP's knowledge) with the intention that CIP would formally approve them for addition to the list in the Operations Manuals. Therefore there are 5 new POIs that should be included in any list prescribed by the Commission, and have been included in our list at Appendix 1 as the list of POIs operational as at 31 December 2019.
- In addition, the suggestion that there should be a "1:1 relationship" between a POI and end-user in a UFB candidate area also does not address situations where an end-user or access point is outside a UFB candidate area.
- The most significant example of this situation is a layer 1 DFAS service between a remote non-building access point (NBAP) (such as a mobile tower) or some other end-user's premises (e.g. a factory) and a rural central office building or exchange that is not within a UFB candidate area. Chorus understands that these services are intended to fall within the scope of Part 6 regulation. However, in the case of these services there is no layer 2 POI associated with the service because the service is provided outside of the UFB initiative, and in fact is outside of a candidate area. It would be artificial and inconsistent with the way in which the services are provided to assign these access points to a notional POI within the UFB initiative. The relevant service and regulated fibre network is between the NBAP and layer 1 handover point. This again is consistent with the Commission specifying layer 1 points of interconnection under section 231.
- The figure below illustrates a rural case (based on Apiti, in the northern Rangitikei). There is a DFAS service provided from the CO (and layer 1 point of interconnection) at Apiti, connected by a commercial backhaul service to the layer 2 point of interconnection in Palmerston North. Apiti is outside of all UFB candidate areas.

FORMATTING THE LIST

- Generally, we agree with the Commission's proposed format and content of the list of points of interconnection. We agree that the physical addresses should be provided on a confidential basis only.
- While we support the Commission's proposed approach in paragraph 34 of its Paper (to specify the related geographic areas serviced by a specified point of connection), the Commission's proposed table reflects the difficulty of specifying the relevant geographic area in this format. While information about points of interconnection changes relatively infrequently, this geographic information would be difficult to include and keep up to date in a table like the one proposed, as UFB2 is still being built. We think it is sufficient for the table to specify the location of the layer 2 POI it was created to service by referring to the UFB1 candidate area (as all UFB1 POIs are also UFB2 POIs), 15 and have proposed this in Appendix B.
- 40 As noted in our summary, we have attached (see Appendices B-D):
 - 40.1 An updated list of "Chorus POIs" that corrects errors and includes additional POIs that are currently operational;
 - 40.2 A confidential table with planned or in progress layer 2 points of interconnection; and

40.3 Tables for layer 1 points of interconnection (in line with our position above) – one for UFB1 and one for UFB2. These should be separated from the layer 2 table as there are a much greater number of layer 1 points of interconnection than layer 2 POIs.

PROCESS FOR CHANGING PRESCRIBED POINTS OF INTERCONNECTION

The current context

- 41 Chorus recognises points of interconnection are of major significance for both Chorus and RSPs. Changing them is not undertaken lightly. However, as a responsible and prudent network operator Chorus will from time to time need to add or remove points of interconnection for various reasons. Planning points of interconnection is a complex balance of commercial, technical and customer risk management. The main drivers for adding points of interconnection are that capacity at existing points of connection need to be managed to avoid a risky concentration of connections. This is because there are existing constraints that impede Chorus' ability to support bandwidth and connection growth or for improved resilience of Chorus and RSP networks.
- Since the introduction of UFB a number of new points of interconnection have been added, which provide options for RSPs. Existing points of interconnection have in some cases become 'capped' in terms of capacity in third party sites where Chorus has not been able to obtain permission from the relevant third party to add equipment or augment existing equipment, e.g. Mayoral Drive, Glenfield, and Wellington. Where a site is capped Chorus has made managed capacity by establishing an alternative site to serve growth. Recent growth above previous forecasts (partly spurred by Rugby World Cup preparation) has meant that additional POIs were added earlier in 2019 under some urgency (these have not yet been formally added to the Operations Manual although change process is in flight with industry and CIP).
- New points of connection have to date been optional RSPs are not forced to migrate if they have sufficient capacity at existing POIs.
- The change processes are currently based on contractual arrangements with RSPs (which include consultation requirements using contractual mechanisms, such as the Change Management and Product Forum¹⁶), followed by approval by CIP where required by the NIPA. Where changes are driven by wider network configurations, CIP generally approves the changes to points of interconnection as a necessary consequence of such network changes.
- CIP has taken a pragmatic approach to the addition of, and identification of, points of interconnection where the NIPA wording doesn't make sense. For example, under the UFB1 NIPA it was envisaged that the candidate areas of Waiheke Island, Waiuku and Pukekohe would be served by their own POIs. However in practice it was more

prudent and efficient to manage the network by diverting handovers to central Auckland POIs (i.e. Mayoral Drive, Mt Eden and Glenfield POIs). This effectively meant that the five original Auckland candidate areas of Auckland North, Auckland South, Pukekohe, Waiuku and Waiheke Island were served by three central POIs, i.e. it removed the need for these new POIs. This was a joint Chorus- and RSP-led solution that benefitted all parties, as it meant that neither had to invest in expensive equipment for a relatively small area that could be more efficiently and cost effectively served by other POIs. CIP acknowledged this and the necessary network configuration was approved.

To date, we have only added new points of interconnection, but there is a real possibility that conditions may one day exist where it would be appropriate to remove a POI, for example where a site is uneconomic to maintain or repair (e.g. due to structural issues caused by the Christchurch earthquakes to the Christchurch Exchange), or where inability to add or augment equipment to some sites may render those sites unusable as points of interconnection. While we do not expect this to happen in the immediate future, it is likely to be an issue in the next three to five years.

Process going forward

- The Commission is able to prescribe new points of interconnection or amend an existing notice listing points of interconnection.
- We appreciate the Commission's current process regarding the initial list of points of interconnection, including providing consultation. This is useful to ensure that the transition from the current framework governed by the NIPA to the legislative framework is smooth and that the Commission is fully informed so that its prescribed list reflects the points of interconnection in operation. This has been a useful exercise in clarifying the content and format of the proposed list.
- Once there is an established list of existing points of interconnection in an agreed format as a result of this initial process, we anticipate that the Commission would exercise its powers under section 231 in a similar manner to the way CIP has done so under NIPA. CIP has been satisfied that if the industry has been consulted (where the WSA requires) then the industry is best placed to determine point of interconnection changes. In particular, as the WSA continues to be in force and contractually oblige an appropriate level of industry consultation for certain proposed changes, we would not envisage that further public consultation would be needed before the Commission prescribed changes to points of interconnection that had been through this consultation process.
- It is vital that the Commission recognises the importance for Chorus and RSPs to have the ability to change points of interconnection when the network constraints or limitations require it (including adding or withdrawing a point of interconnection).¹⁷
- Any substantive change to the existing process (especially if it involves additional steps such as public consultation by the Commission) could hamper flexibility and

efficiency. Although the actual declaration of points of interconnection changes is relatively infrequent, the process for consideration of appropriate points of interconnection, including the possibility of new points of interconnection, is an ongoing and nearly continuous one. The introduction of new process steps or a reduction in the speed at which point of interconnection changes are approved could lead to potential efficiencies in the fibre network not being realised or being delayed.

A corrected version of the Commission's list is attached as Appendix B, this contains layer 2 POIs only. We propose that the Commission specify a separate table for layer 1 points of interconnection and we have provided a list in Appendix D. We have also provided a confidential list (Appendix C) of planned or works in progress layer 2 POIs, this demonstrates the dynamic and evolving nature of the network, and the necessity to preserve our ability to change and add POIs where appropriate and required.

Yes, we agree that each specified point of interconnection should have specified end-user premises or access points within a point of interconnection associated area whether UFB initiative or not. We are not sure what the best way to achieve this is, as the proposed table doesn't appear to do this (and it is probably not practicable to do so within the table).
5	Are you aware of any end-user premises, buildings, or other access points for whom fibre fixed line access services are available but that are not, or cannot be, associated with a UFB initiative POI? If so, how should we treat these?	Some layer 1 services are not associated with a layer 2 POI, but are associated with a layer 1 point of interconnection. However, this would typically occur where the layer 1 service is not associated with the UFB initiative. These (non-UFB initiative) layer 1 services are associated with a CO through which the service is delivered, and is the layer 1 point of interconnection (i.e. not a UFB initiative point of interconnection). These are not included in Appendix D, but they should be included in the Commission's notice of specified points of interconnection. We are working on this list and will share this with the Commission. It is unlikely that for any new locations where we offer layer 2 services, the layer 2 service would not be associated with an existing layer 2 POI. However, new layer 1 services might require addition of a new CO to the list of layer 1 points of interconnection. To reiterate, and as described above, the network is dynamic and continuously evolving and it is vital that network operators' ability and flexibility to make

		prudent and efficient changes where appropriate is not unreasonably curtailed.
6	Do you see any advantages in alternative approach of identifying related end-user premises, buildings, or other access points by reference to SFAs?	No. We consider this would be circular – if defining points of interconnection is needed in order to identify SFAs, then SFAs cannot be used to define POIs.
7	In circumstances where there is a future extension to a fibre network outside of the UFB initiative, rather than specifying a new POI, should we specify that end-user premises, buildings, or other access points served by the new fibre network be related to an existing UFB initiative POI?	Generally speaking and where prudent to do so, our starting point is existing UFB points of interconnection (see above Question 5), but it is subject to demand and capacity where we need flexibility to respond, which may require new points of interconnection.
8	Are there any other details we should provide for each POI?	Layer 1 points of interconnection should be included. We have no additional changes.
9	Are you aware of any UFB initiative POIs that are not in the list in Attachment A but will exist as at the close of 31 December 2019?	Yes – as noted above we have attached an updated list.
