### Question

Do you agree that the UFB initiative POIs are those POIs that were implemented to satisfy the single POI per candidate area requirement under the NIPAs?

All premises, buildings and other access points in our coverage area can be serviced by establishing a Fibre Handover Point (ENNI) at either of our two Points of Interconnect (POI). Our network has continued to grow through the development of new greenfields subdivisions, and any additional addresses associated with these extensions to our network can be serviced by either of our POIs. It is expected that any future fibre network extensions that are adjacent to our existing network will be serviced by either of our POIs.

Having said this, and to answer the question more specifically, whether a new POI is required or not is a matter of the dimension and location of the growth. It could be possible that a new POI will be required depending on the location and size of growth.
