**Electricity Distribution Services (Top Energy Limited)
Default Price-Quality Path Amendment Determination 2015**

Pursuant to Part 4 of the Commerce Act 1986 (the **Act**) the Commerce Commission makes the following determination:

1. SHORT TITLE

This determination is the Electricity Distribution Services (Top Energy Limited) Default Price-Quality Path Amendment Determination 2015.

2. APPLICATION

This determination amends the *Electricity Distribution Services Default Price-Quality Path Determination 2015* [2014] NZCC 33 (the **EDB DPP Determination**).

3. COMMENCEMENT

This determination comes into force on 1 April 2015.

4. INTERPRETATION

Unless the context otherwise requires:

- (a) terms used in this determination that are defined in the **Act** but not in this determination have the same meanings as in the **Act**;
- (b) terms used in this determination that are defined in the **EDB DPP Determination** have the same meanings as in the **EDB DPP Determination**.

5. AMENDMENTS

- 5.1 In Table 4A.1 of Schedule 4A of the **EDB DPP Determination**, replace the SAIDI Limit, SAIDI Unplanned Boundary Value, SAIFI Limit, and SAIFI Unplanned Boundary Value applicable to Top Energy Limited as follows:

Non-exempt EDB	SAIDI Limit	SAIDI Unplanned Boundary Value	SAIFI Limit	SAIFI Unplanned Boundary Value
Top Energy Limited	516.675	29.364	6.248	0.347

- 6.1 In Table 5B.1 of Schedule 5B of the **EDB DPP Determination**, replace the SAIDI Target, SAIDI Collar, and SAIDI Cap applicable to Top Energy Limited as follows:

Non-exempt EDB	SAIDI Target	SAIDI Collar	SAIDI Cap
Top Energy Limited	435.4607	354.2460	516.6753

- 6.2 In Table 5B.2 of Schedule 5B of the **EDB DPP Determination**, replace the SAIFI Target, SAIFI Collar, and SAIFI Cap applicable to Top Energy Limited as follows:

Top Energy Limited	5.4359	4.6240	6.2478
