We have updated the [Draft] Electricity Distribution Information Disclosure (Aurora Energy Limited) Amendment Determination 2021 (draft determination) that accompanied our draft decision on additional accountability measures for Aurora Energy Limite (Aurora) to correct some minor formatting errors. The updated draft determination is not materially different to the original version we published on 31 March 2021. Compared to the original version, the updated draft determination:

- a) shows the following definitions from the original version as track-changes:
 - 'Planned accumulated SAIDI limit'
 - 'Planned accumulated SAIFI limit'
 - 'Planned interruption cancelled without notice'
 - 'Planned interruption cancelled with notice'
 - 'Planned SAIFI values'
- b) corrects a formatting error in the list of subclauses in clause 2.8.5A so there is only one subclause '(1)'
- shows the references in **bold** to 'SAIDI' and 'SAIFI' in paragraphs (1) and (2) of Attachment B as formatting trackchanges.
