Official Information Act #22.169 - Response

- 1. We refer to your request received on 2 May 2023 and clarified on 4 May 2023 for information relating to the Commerce Commission (the Commission) residential building supplies market study.
- 2. You have requested all correspondence between the following parties and the Commission in the period 2 October 2022 to 6 December 2022.
 - 2.1 Building Industry Federation
 - 2.2 Fletchers
 - 2.3 Carters
 - 2.4 Incumbent material suppliers
 - 2.5 BRANZ.
- 3. As discussed, we have agreed with you that:
 - 3.1 administrative emails, such as cover emails, administrative emails to all stakeholders, or emails to and from parties checking the confidentiality status of information prior to final report publication, are out of scope of the request and will not be provided; and
 - 3.2 your reference to "incumbent materials suppliers" is intended to refer to any industry participants / secondary parties / interested parties who are suppliers of building products (not just the major building supplies merchants).

4. On 30 May 2023 the Commission extended the time frame to communicate our decision on your request to 31 July 2023.

Our response

- 5. We identified a set of documents within scope of your request and then consulted with the relevant parties.
- 6. We are releasing to you the documents listed in **Appendix A** below.
- 7. As indicated in Appendix A, we have redacted certain information in some documents as we consider good reasons exist to:
 - 7.1 protect the privacy of natural persons (section 9(2)(a) of the OIA); and/or
 - 7.2 protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information (section 9(2)(b)(ii) of the OIA).
- 8. We have withheld two documents in full. These documents are listed in **Appendix B** below.
 - 8.1 We have withheld one document under section 6(c) of the OIA as it relates to an ongoing investigation. We consider good reasons exist to withhold this document as release would be likely to prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial.
 - 8.2 We have withheld one document in full under section 9(2)(b)(ii) of the OIA as release would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.
- 9. We consider that good reasons exist for withholding information under section 9 and this is not outweighed by other considerations which would make it desirable, in the public interest, to make the information available (section 9(1) of the OIA).

10. We are currently finalising our response to you regarding our correspondence with Mitre 10. We will release the remainder of our response to you without undue delay.

 - 7.3 protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied (section 9(2)(ba)(i) of the OIA).
- 8. We have withheld two documents in full to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information (section 9(2)(b)(ii) of the OIA). These documents are listed in **Appendix B** below.
- 9. We consider that good reasons exist for withholding information under section 9 of the OIA and this is not outweighed by other considerations which would make it desirable, in the public interest, to make the information available (section 9(1) of the OIA).
