## Request for information on the Commission SLE/SLU/UBA investigation

This is a request for information in support of the Commission's investigation, announced today, into a potential breach by Telecom of the Separation Undertakings in relation to the supply of Unbundled Bitstream Access services (UBA) taken in combination with Sub-Loop Unbundled services (SLU) and/or the Sub-Loop Extension services (SLES).

The Commission requests the following information in relation to the investigation:

- Can you confirm whether you have purchased, or tried to purchase, UBA from Telecom in conjunction with SLES? If so, on what terms and conditions and at what prices?
- We have the following record of your correspondence with Telecom regarding your request for UBA in conjunction with SLES and SLU, can you confirm this is accurate/fill in the gaps?
  - 11 March 2009 Vodafone met with Telecom, mainly discussed loyalty offers but also SLES+UBA
  - 27 May 2009 Telecom Dialogue Product Forum Vodafone spoke with Telecom re SLES+UBA
  - 29 May 2009 Vodafone met with Telecom, mainly discussed loyalty offers but also SLES+UBA
  - 16 June 2009 Vodafone met with Telecom, mainly discussed loyalty offers but also SLES+UBA
  - 24 June 2009- Vodafone emailed written request to Telecom for SLES+UBA service,

as previous communications were verbal only

- 8 July 2009 Vodafone met with meeting with Telecom + Chorus re SLES+UBA
- 14 July 2009 Vodafone met with Telecom, discussed loyalty offers & SLES+UBA
- 19 August 2009 Email to Vodafone from Telecom promising a response on SLES+UBA in September
- 27 August 2010 Telecom commercial offer communicated to Vodafone (and other customers)
- 8 September 2010 Telecom response to Vodafone proposing a \$7.5 discount
- 3 Copies of any board/executive papers regarding the UBA with SLU+SLES issue, and investment in exchanges subject to cabinetisation, including any decision papers, reports, or business plans.

Please also provide the Commission with any other information you believe is pertinent to this investigation.

The Commission may seek additional or supplementary information, as it deems reasonably appropriate for completing its investigation.

Please note any information in your response for which you seek confidential treatment. The Commission does not intend to publicly release or share the information requested in this letter, so we see no need for a confidentiality order at this time. The Commission may, however, consider putting a s100 Confidentiality Order in place at party's request prior to any consultation the Commission may consider appropriate during the course of the investigation.
