#### PRICE AND SERVICE DESCRIPTION

Provide a detailed description of the service for which a pricing review determination is sought and specify the specific price or prices for which a review is sought.

- Telecom seeks a review of the price for the designated access service entitled Chorus' unbundled copper local loop network service ("UCLL"). Specifically, those parts of the Final Determination on the benchmarking review for the unbundled copper local loop service issued by the Commerce Commission ("Commission") on 3 December 2012 (Decision No. NZCC 37) ("the Determination") that relate to:
  - 2.1 the updated geographically averaged monthly UCLL service price of \$23.52;
  - 2.2 The geographically de-averaged prices for UCLL;
  - 2.3 Certain one-off charges and circumstances when certain one-off charges can be levied.

## JUSTIFICATION FOR APPLICATION

On what grounds is a determination being sought? Explain in detail why the applicant considers, given the purpose of the Act, that the Commission should make a determination:

- 3.1 The ground on which an application is made is that Telecom is a party to the UCLL Determination. From 1 December 2014 Telecom will be an access seeker for UCLL. Prior to 1 December 2014 the price Telecom pays to Chorus for the unbundled copper low frequency service ("UCLF" or baseband), the input to our retail voice services, is the same as the UCLL price determined by the Commission. Furthermore, Telecom is the largest purchaser of the designated access service, Unbundled Bitstream Access service ("UBA"), from Chorus. The price for UBA is determined with reference to the UCLL price and accordingly the FPP Determined price for UCLL has a material bearing on the price we pay for UBA.
- 3.2 Telecom is mindful that a Price Review Determination in which the Commission is asked to apply a final pricing principle has not previously taken place in New Zealand. We are also aware that Chorus Limited ("Chorus"), the regulated UCLL Access Provider, has informed the New Zealand Stock Exchange, and set out in its submission on Unbundled Bitstream Access pricing dated 2 February 2012, that it intends to apply for a review of the Determination and request that the Commission apply the FPP.
- 3.3 Because it is the first such application in New Zealand we are mindful that there is some uncertainty in respect of the FPP process, the parties' rights within it and the likely method for proceeding..
- 3.4 In the circumstances Telecom files this application in order to protect its procedural rights in the Final Pricing Review process by ensuring it has the procedural protections and rights that are accorded applicants in the Final Pricing Review determination process..
- Our objective is simply to obtain regulatory certainty in respect of our input costs through the application of a competitively-neutral and appropriate TSLRIC cost-based price to the UCLL service.

## PARTIES TO DISPUTE

Although the Determination under review is a STD under section 30M and not a determination under section 27 we set out our standing in this section for completeness.

4.1 Telecom is a telecommunications company that supplies telecommunications services at retail and wholesale. We purchase various regulated and commercial services from Chorus as inputs to enable us to provide retail services to end-users;

4.2 The Access provider is Chorus Limited.

# REQUIREMENTS FOR APPLICATION

  - 6.1 The initial determination based on the benchmarked prices under the IPP may not have adequately approximated the FPP. There are many inputs into TSLRIC cost models, many of which may be subject to New Zealand-specific factors that cannot be sufficiently accounted for in an international benchmarking process. We simply will not know to what extent, or not, the initial price reflects the true TSLRIC cost of the service until a TSLRIC costing exercise is undertaken. T.

#### TERMS OF DETERMINATION

- 7.1 We think that prices that reflect the reasonable TSLRIC costs to provide the UCLL service (including a reasonable margin) should be determined.
- 7.2 We intend to make more detailed submissions on how that price should be determined and what a likely final price should be during the FPP process.
- 7.3 Further information in support of the proposed price and proposed process will be provided during the course of the FPP process.
- 7.4 We will provide more detailed submissions on why the application supports the purpose during the scoping phase of the FPP process.
- Propose the terms and conditions on which the applicant considers the determination should be made, and justify each why each term and condition proposed is required.
  - 8.1 We intend to make more detailed submissions on terms and conditions during the FPP process but at this stage do not have any detailed objections to the balance of the STD terms other than the price.
- Propose the actions (if any) that the applicant considers a party to the determination must do or refrain from doing, and justify why each action proposed is required.

- 9.1 We intend to make further submissions on this during the FPP process.
- In respect of a determination under section 27 of the Act, propose the period of time for which the applicant considers the determination should apply, and justify why the period proposed is appropriate.
