- We refer to your Official Information Act 1982 (OIA) request received on 12 1. September 2022 for information about Commerce Commission (Commission) staff turnover and engagement with SenateSHJ. The scope of your request is:
 - 1.1 a list of all staff members who have joined the Commission and a list of all staff members who have left the Commission over the past two years including their job titles and names; and
 - 1.2 results from any staff engagement surveys over the past two years;
 - 1.3 if the Commission has engaged SenateSHJ over the past two years, a budget breakdown of the cost of SenateSHJ's services in that time, separated by field (e.g., telecommunications, groceries, airports etc).
- 2. We note it is your preference to receive the requested information in Excel format, where possible.

Our response

3. We have decided to grant your request in part.

Staff turnover

4. We have provided information about Commission staff turnover for the years ended 30 June 2020, 2021 and 2022 below.

- 6. We have provided an Excel spreadsheet containing a list of all staff members who have joined the Commission and a list of all staff members who have left the Commission during the relevant period,² including their job titles (**Attachment A**). We have indicated whether each staff member was employed on a fixed term or permanent contract.
- 7. We have withheld staff names under section 9(2)(a) of the OIA to protect their privacy, but have indicated where a joiner also left during the relevant period.
- 8. We consider that good reason exists for withholding the staff names and is not outweighed by other considerations which would make it desirable, in the public interest, to make the names available (section 9(1) of the OIA).

Engagement surveys

9. In response to paragraph [1.2] of your request, the Commission conducts employee feedback surveys quarterly. The surveys produce an overall engagement score which measures employees' sense of loyalty, satisfaction, and belief in the organisation. The Commission's current results place us in the upper quartile of public sector organisations against the international public sector benchmark of the engagement tool we use. The results of the surveys conducted during the relevant period are below.
