#### 1.2 DETERMINATION AMENDED

1.2.1 This determination amends the Aurora Energy Limited Electricity
Distribution Customised Price-Quality Path Determination 2021 [2021] NZCC
3 (principal determination).

#### 1.3 COMMENCEMENT

1.3.1 This determination comes into force on [day] [month] 2024.

#### 1.4 PRINCIPAL DETERMINATION AMENDMENTS

- 1.4.1 In Schedule 1.3 of the principal determination,
  - (a) in the row labelled "31 March 2022" replace the value "\$103,633,000" with "\$105,065,000".
  - (b) in the row labelled "31 March 2023" replace the value "\$99,660,000" with "\$101,007,000".
  - (c) in the row labelled "31 March 2024" replace the value "\$96,596,000" with "\$97,902,000.
  - (d) in the row labelled "31 March 2025" replace the value "\$93,722,000" with "\$94,990,000".
  - (e) in the row labelled "31 March 2026" replace the value "\$90,867,000" with "\$92,096,000".
- 1.4.2 In Table 2.2.2 (sum of the forecast value of commissioned assets for each CPP assessment period) of Schedule 2.2 of the **principal determination**,
  - (a) in the row labelled "31 March 2022" replace the value "\$76,398,000" with "\$84,484,000".
  - (b) in the row labelled "31 March 2023" replace the value "\$65,392,000" with "\$71,271,000".

- (c) in the row labelled "31 March 2024" replace the value "\$77,959,000" with "\$89,309,000".
- (d) in the row labelled "31 March 2025" replace the value "\$71,489,000" with "\$81,717,000".
- (e) in the row labelled "31 March 2026" replace the value "\$65,748,000" with "\$74,807,000".
