- This determination amends the Gas Transmission Information Disclosure Determination 2012, as previously amended, ("principal determination").
- The included amendments which are secondary legislation are made under the Legislation Act 2019 and Part 4 of the Commerce Act 1986.

Under Part 4 of the Commerce Act 1986 the Commerce Commission makes the following determination:

TITLE

1. This determination is the Gas Transmission Information Disclosure Amendment Determination 2022.

INTERPRETATION

2. In this determination the words or phrases in **bold** type bear the following meanings:

principal determination means the Gas Transmission Information Disclosure Determination 2012 [2012] NZCC 24.

DETERMINATION AMENDED

3. This determination amends the **principal determination**.

COMMENCEMENT

4. This determination comes into force on the date after which notice of the determination is given in the New Zealand Gazette.

PRINCIPAL DETERMINATION AMENDMENTS

- 5. In clause 1.4.3, amend the definition of "**IM determination**" to read "means the Gas Transmission Services Input Methodologies Determination 2012 [2012] NZCC 28, including any amendments to that determination".
- 6. In Schedule 16, amend the definition of "Mid-point estimate of vanilla WACC" to read "means the mid-point estimate of vanilla WACC determined by the Commission for that disclosure year under clause 2.4.1(1) of the IM determination".
- 7. In Schedule 16, amend the definition of "Mid-point estimate of post tax WACC" to read "means the mid-point estimate of post tax WACC determined by the Commission for that disclosure year under clause 2.4.1(2) of the IM determination".

Explanatory note:

- 1. We made a number of amendments to the input methodologies (IMs) applying to gas transmission services as part of the default price-quality path reset for gas transmission businesses for the third regulatory period commencing on 1 October 2022.
- 2. A number of the IM amendments affect the gas transmission information disclosure (ID) requirements. The gas transmission ID determination previously defined "IM determination" as meaning "the Gas Transmission Services Input Methodologies Determination 2012 [2012] NZCC 28, including amendments in effect at the time this determination comes into force". (Underlining added)The possible effect of this definition was to exclude future IM amendments, including those we have made now, from applying to ID disclosures made after the gas transmission ID determination of "IM determination" in the gas transmission ID determination to make it clear that any IM amendments for ID will automatically apply to future ID disclosures
- 3. We also amended two definitions in Schedule 16 of the gas transmission ID determination that refer to a weighted average cost of capital (WACC) estimate "for the five year period". These amendments reflect our IM amendments published on 25 March 2022 which enable us to set an ID WACC that reflects the length of the regulatory period for the relevant default-price quality path, and not only the usual five-year regulatory period length.
