### Official Information Act #22.193 - Response

- 1. We refer to your request received on 29 May 2023 for information about the behaviour of taxi drivers/small passenger vehicle operators. Specifically, you have requested:
  - 1.1 the number of complaints received by the Commerce Commission (the Commission) about small passenger vehicle operators/taxis, over the last five years, broken down by year, category and outcome; and
  - 1.2 any other relevant information held on file.
- 2. We have treated this as a request for information under the Official Information Act 1982 (OIA).

#### **Our response**

#### Complaints

- 3. Over the last five years,<sup>1</sup> the Commission has received **235** complaints or enquiries about taxi drivers/small passenger vehicle operators.
  - 3.1 2018<sup>2</sup> 19 complaints or enquiries
  - 3.2 2019 53 complaints or enquiries
  - 3.3 2020 34 complaints or enquiries



- 3.4 2021 53 complaints or enquiries
- 3.5 2022 54 complaints or enquiries

- 4. The information you requested is provided in Appendices A to F below, one for each year.
- 5. Given the number of complaints, we have not been able to provide summaries of each complaint, but we have set out the relevant issue.
- 6. Information in enquiry numbers ENQ0547060, ENQ0547062, ENQ0547064 and ENQ0547191 has been withheld under section 6(c) of the OIA because making available the information would be likely to prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial.

These reasons include, but are not limited to, circumstances where we consider the complaint is better suited to private action by the complainant, the complaint is subject to the jurisdiction of another agency, or where there is no clear breach of the law. However, each complaint and enquiry provides information that is valuable to the Commission. This contributes to future priorities, potential issues for us to watch closely or emerging issues to refer to our policy agency, MBIE. In this regard, we will monitor complaints or information we receive as we look to future prioritisation.
