## Official Information Act #22.042 Response

- 1. We refer to your request received on 30 August 2022, which was clarified and amended on 6 September 2022.
- 2. You have requested the following information, for the last five years:
  - 2.1 the amount the Commerce Commission (the Commission) has spent on internal training for diversity, inclusion, equity, and anti-racism initiatives;
  - 2.2 the names of the organisations that provided the training;
  - 2.3 the names of the training sessions; and
  - 2.4 whether the training sessions are compulsory for Commission staff.
- 3. We have treated this as a request for information under the Official Information Act 1982 (OIA).
