# Introduction

The Commission was required (under subpart 3 of Part 4 of the Commerce Act) to determine input methodologies to apply to the regulation of specified airport services, electricity distribution and transmission, and gas pipeline services by 31 December 2010.

The Commission made its input methodologies determinations on 22 December 2010 and published the determinations in the New Zealand Gazette on 20 January 2011.

In making these determinations, the Commission carried out a significant amount of consultation with interested parties. The key steps in the consultation process were:

- June – November 2009: Consultation on the Input Methodologies Discussion Paper (including a conference and a workshop on the cost of capital)
- December 2009 – March 2010: Consultation on the Emerging Views Papers (including a range of workshops)
- May – September 2010: Consultation on Draft Input Methodologies Determinations and Reasons Papers
- October – November 2010: Technical consultation on Revised Draft Input Methodologies Determinations
