Transpower IPP – 14 November 2019 final decisions: Requests for Information

- 1. To help inform our reset of the Transpower individual price-quality path (IPP) for the Regulatory Control Period starting 1 April 2020 (RCP3), we requested additional information from Transpower. These Requests for Information (RFIs) followed a structured process agreed between Transpower and us.
- 2. We issued these RFIs where we identified areas for us to perform further analysis in relation to our evaluation of Transpower's proposal. The information from these RFIs, along with Transpower's RCP3 proposal, the Verifier's report, EMCa's report on Transpower's ICT expenditure, EMCa's supplementary report on Transpower's ICT expenditure, other supporting documents provided by Transpower as part of its proposal, and submissions we received from interested persons, has helped inform our decisions.
