

CLARIFICATION OF THE STANDARD TERMS DETERMINATION ON TELECOM'S UNBUNDLED COPPER LOCAL LOOP NETWORK BACKHAUL SERVICE

DECISION NO. 698

Clarification under section 58 of the Telecommunications Act 2001 (the 'Act') of Decision 626

The Commission:

Summary of Application and Initiation:

The Commission received an application for clarification from Telecom (Chorus) to clarify Decision 626 to remove five exchanges from the table in Appendix C of Schedule 5, as the exchanges did not exist at the date of Decision 626.

Date of clarification:

Request for clarification

- 1. On 27 June 2008, the Commerce Commission acting under the Telecommunications Act 2001 (the **Act**) made a standard terms determination for the designated service Telecom's unbundled copper local loop network backhaul (**UCLL Backhaul STD**).
- 2. On 8 September 2010, Telecom (Chorus) requested a clarification under section 58 of the Telecommunications Act 2001 (Act) to the UCLL Backhaul STD to remove five exchanges from the table in Appendix C of Schedule 5 of the STD, as the exchanges did not exist on 27 June 2008 and had been included in the Schedule in error. This clarification was considered by the Telecommunications Carriers' Forum (TCF) Working Party on 26 August 2010 and approval was given for these amendments by the parties in attendance Vodafone, TelstraClear and Telecom.

The Commission's Decision

3. The Commission's Decision is that the five exchanges Kaiteriteri (KTI), Piha (PIA), Rotowaro (ROW), Springburn (SB) and Te Akau (TEF) be removed from the table in Appendix C (Radial distances for UCLL Backhaul Service) of Schedule 5 of the UCLL Backhaul STD, given that these were mistakenly included, and did not exist on 27 June 2008 and had been included in the Schedule in error.

Analysis

- 4. Schedule 5 of the UCLL Backhaul STD sets out the UCLL Backhaul POI site related information, and as part of this, lists the radial distances to the Parent POI.
- 5. Telecom (Chorus) has advised that contained in this list are five rural exchanges that should not be listed in this Schedule as they no longer exist. These exchanges were replaced by cabinets before the date of the UCLL STDs due to property consolidation and reduced space requirements, or they had been damaged by fire. The exchanges are listed in the table below.

6. It is the Commission's view that it is not necessary, or appropriate, for these exchanges to remain in Schedule 5 of the UCLL Backhaul STD.

Decision

- 7. No appeal is pending in respect of the determinations proposed to be modified in this Decision, satisfying section 58(1)(c) of the Act.
- 8. In accordance with section 19(c) of the Act, the Commission considers that the clarification set out in this Decision is likely to best give effect to the purpose set out in section 18 of the Act.
