Official Information Act #23.038 – Auckland International Airport Limited Correspondence

- 1. We refer to your request received on 25 August 2023 for information about Auckland International Airport Limited's (AIAL) correspondence with the Commerce Commission (Commission).
- 2. Specifically you requested:
 - 2.1 any submission or cross submission to the IM Review made by AIAL which has not been made publicly available per the IM Review process;
 - 2.2 any correspondence between AIAL and the Commission between 1 November 2022 and 25 August 2023; and
 - 2.3 any correspondence between Russell McVeagh and the Commission between 1 November 2022 and 25 August 2023.
- 3. On 28 August 2023, you clarified that only correspondence from Russell McVeagh on behalf of AIAL and New Zealand Airports Association (NZAA) was requested for [2.3] above.
- 4. We have treated this as a request for information under the Official Information Act 1982 (OIA).

Our response

- 5. We have decided to grant your request.
- 6. In response to your request at [2.2], the Commission's IT team performed a search across the Commission's email services to collate all correspondence between AIAL

and the Commission for the specified period. This process would also capture information for your request at [2.1].

- 7. In response to your request at [2.3], staff were canvassed as to whether they had had correspondence from Russell McVeagh on behalf of AIAL and NZAA.
- 8. A list of the correspondence can be found in **Appendix A**. We consider that good reasons exist to withhold certain information in Appendix A to protect the privacy of natural persons under section 9(2)(a) of the OIA
- 9. Six documents have been withheld in their entirety. One is an employment reference for a staff member, therefore has been withheld under section 9(2)(a) of the OIA. The other five have been withheld under sections 9(2)(b)(ii) and 9(2)((ba)(i) of the OIA, so as not to prejudice the commercial position of AIAL and because they were submitted to the Commission in confidence and the supply of such information in the future is in the public interest. These documents are set out in **Appendix B**.
- 10. We consider that good reasons exist for withholding information under section 9 and this is not outweighed by other considerations which would make it desirable, in the public interest, to make the information available (section 9(1) of the OIA).

- 11. If you are not satisfied with the Commission's response to your OIA request, section 28(3) of the OIA provides you with the right to ask an Ombudsman to investigate and review this response. However, we would welcome the opportunity to discuss any concerns with you first.
