## Official Information Act #21.018 - Pyramid schemes

- 1. We refer to your Official Information Act 1982 (OIA) request transferred to the Commerce Commission (**Commission**) from the New Zealand Police on 9 August 2021 for the following information:
  - 1.1 details of all investigations into 'pyramid schemes' (as defined by the Commission)¹ each year for the past ten years, including outcomes of those investigations and punishments imposed in the courts; and
  - any records that summarise the social demographics targeted by pyramid schemes.

## Our response

- 2. We have decided to grant your request.
- 3. The Commission has made enquiries into ten alleged pyramid schemes during the past ten years;<sup>2</sup> including three live matters.
- 4. We have provided details of the matters below. Please note that we have provided limited details for one of the live investigations, under section 6(c) of the OIA as the disclosure of these would likely prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial.
- 5. You can find further information about the investigation outcomes in the Enforcement Response Guidelines on our website.<sup>3</sup>
