## Official Information Act #23.200 - Response

- 1. We refer to your request received on 5 February 2024 for information about warning letters published by the Commerce Commission (the Commission). Specifically, you asked for a table which shows:
  - 1.1 How many times a warning letter has been issued to a company/person over the past five years for any matter including potential FTA breach etc
  - 1.2 How many times a media release accompanied that warning letter over the past five years
  - 1.3 Where a warning letter has been issued and no media release issued, can you please provide a copy of the warning letter (again past five years only)
- 2. We have treated this as a request for information under the Official Information Act 1982 (OIA).

## Our response

- 3. We have decided to grant your request.
- 4. In response to your request at [1.1], the Commission has issued 73 warning letters over the past five years (ie, the period 5 February 2019 to 5 February 2024 (the relevant period)).
- 5. In response to your request at [1.2], 26 of the 73 warning letters issued in the relevant period were accompanied by media releases.

- 6. With the evolving media landscape, the Commission has adopted a more flexible approach to communicating warnings and other enforcement outcomes. Except in instances where there is a special reason not to do so, the Commission publishes all warning letters on its website. In the past five years 26 of the 73 warning letters were accompanied by a media release.
- 7. We set out in **Appendix A**, in response to your request at [1.3], links to the 47 warning letters on our website, where no media release was published. We have also included a link to the relevant case register page for each matter.
