The New Zealand Nurses Organisation *Tōpūtanga Tapuhi Kaitiaki o Aotearoa* (NZNO) appreciates the opportunity to comment on the application from the INC seeking authorisation for an arrangement allowing the INC to restrict its members from marketing formula products for children aged up to 12 months. We apologise for the delayed response, which, as indicated was due to the short consultation timeframe and the difficulty of 'shortcutting' normal processes for member feedback. We note that it is likely that there will be a further opportunity for review should the application go ahead. We have consulted with members and staff, including members of Te Rūnanga, Women's Health College, Neonatal College and College of Primary Health Care Nurses, midwives and professional nursing and policy advisers.

In general NZNO welcomes any action providing regulatory support for the practical implementation of the World Health Organisation (WHO) Code of Breastfeeding and improve the rates of breastfeeding in Aotearoa New Zealand consistent with international recommendations. While new maternity leave provisions critically enable exclusive breastfeeding for six months, they do not support extended breastfeeding as recommended. For that reason we advise *extreme caution* around 'gateway advertising' at a period when mothers are likely to be resuming work. In particular we oppose the use of phrases 'follow on' formula' which may imply that such a product is necessary and/or appropriate for young babies.

NZNO would be happy to provide further information or liaison with our expert members if necessary. Once again, thanks you for the opportunity to comment.
