

Official Information Act #20.226 - Bunnings (NZ) Limited costs

- 1. We refer to your request received on 9 June 2021 for the breakdown of the following costs incurred by the Commerce Commission (**Commission**) in the Bunnings (NZ) Limited court case, ¹ broken down by Court (how much relates to the District Court and how much for the previous High Court, Court of Appeal hearings):
 - 1.1 internal Commission hours;
 - 1.2 amounts paid in external legal fees and which law firms this was paid to;
 - amount paid to individual barristers including but not limited to John Dixon QC, Ian Brockie [sp], Jack Hodder QC; and
 - 1.4 other costs/disbursements.
- 2. We have treated this as a request for information under the Official Information Act 1982 (OIA).
- 3. On 11 June 2021, we referred you to OIA 19.192 published in the OIA register on our website containing the figures to 25 June 2020.²

Our response

4. We have decided to grant your request. The Commission is not able to provide a breakdown of costs by Court as requested. The High Court and Court of Appeal

hearings related to pre-trial applications (largely relating to the evidence to be presented at trial), and the work on them was done in conjunction with preparation for the District Court hearing of the charges.

- 5. We also note that Jack Hodder QC was instructed by Bunnings, not the Commission, on this matter.
- 6. The updated figures, as at 11 June 2021, are below:
