

## NOTICE OF INTENTION

23 FEBRUARY 2022

*Further amended and reissued on 22 August 2023*

### Input Methodologies Review 2023

---

1. Under s 52V of the Commerce Act 1986 (**the Act**), the purpose of this notice of intention is to outline the Commerce Commission's (**Commission**) process and time frames for its review of the input methodologies under Part 4 of the Act in accordance with section 52Y (**IM Review**) of the Act.
2. The input methodologies (**IMs**) that will be reviewed are:
  - 2.1 *Commerce Act (Specified Airport Services Input Methodologies) Determination 2010* (Commerce Commission Decision 709, 22 December 2010);
  - 2.2 *Electricity Distribution Services Input Methodologies Determination 2012* [2012] NZCC 26;
  - 2.3 *Gas Distribution Services Input Methodologies Determination 2012* [2012] NZCC 27;
  - 2.4 *Gas Transmission Services Input Methodologies Determination 2012* [2012] NZCC 28;
  - 2.5 *Commerce Act (Transpower Input Methodologies) Determination 2010* [2012] NZCC 17; and
  - 2.6 *Transpower Capital Expenditure Input Methodology Determination 2012* [2012] NZCC 2.

### The statutory deadline for completing the IM Review

4. Section 52Y(1) requires us to review each IM at least every seven years.
5. The last IM review was substantially completed in December 2016. We deferred decisions on certain areas of that IM review to 2017 (decisions on the Transpower Incremental Rolling Incentive Scheme to June 2017, on the customised price-quality path information requirements for gas to December 2017, and on the related party transaction provisions to December 2017). We also completed our IM review of the Transpower Capital Expenditure Input Methodology Determination in May 2018.
6. We will therefore meet the seven-year statutory deadline for reviewing each IM if we complete our review of the IMs listed in paragraph 2 by December 2023 as set out in our proposed timeframe.

### The Gas DPP3 resets and the IM Review 2023

7. The IM Review will consider all IMs including the IM amendments made as part of resetting the default price-quality paths (**DPPs**) for gas distribution and gas transmission businesses in May 2022 (**Gas DPP3 resets**).<sup>2</sup>
8. The outcomes of the IM Review 2023 will not apply to the Gas DPP3 resets, but only to future DPP resets, that is, to the DPP resets for the fourth regulatory period and later.
