## **Aurora Energy Electricity Distribution Services Customised Price-Quality Path (Compliance Statement Due Date) Amendment Determination 2023**

Under Part 4 of the Commerce Act 1986 (the **Act**), the Commerce Commission makes the following determination:

### **1. TITLE**

1.1. This determination is the Aurora Energy Electricity Distribution Customised Price-Quality Path (Compliance Statement Due Date) Amendment Determination 2023.

### **2. DETERMINATION AMENDED**

2.1. This determination amends the Aurora Energy Limited Electricity Distribution Customised Price-Quality Path Determination 2021 [2021] NZCC 3 (**principal determination**).

### **3. COMMENCEMENT**

3.1. This determination comes into force on the date specified in the notice published in the New Zealand Gazette for this determination in accordance with s 52Q(4) of the Act and s 74(1) of the Legislation Act 2019.

### **4. INTERPRETATION**

4.1. Unless the context otherwise requires:

- 4.1.1. terms used in this determination that are defined in the Act but not in this determination have the same meanings as in the Act; and
- 4.1.2. terms used in this determination that are defined in the principal determination have the same meanings as in the principal determination.

### **AMENDMENTS**

5. In clause 11 of the principal determination, replace clause 11.1(a) so that it reads:

11.1 **Aurora** must –

- (a) provide to the **Commission** a written ‘annual price-setting compliance statement’ in respect of–
  - (i) the first **CPP assessment period**, within 20 **working days** after the start of the first **CPP assessment period**;
  - (ii) **price setting** for the second to fifth **CPP assessment period**, before the start of the relevant **CPP assessment period** (except the third **CPP assessment period** for which **Aurora** must provide the **annual price-setting compliance statement** before 19 April 2023); and
