Official Information Act #19.113

We refer to your Official Information Act 1982 (OIA) request received on 14 January 1. 2020 for copies of the advice issued to 41 businesses referred to in Commerce Commission (Commission) Chair, Anna Rawlings' opening remarks at the Competition Matters conference on 25 July 2019:

> *Our staff reviewed 73 websites for pressure selling tactics. Separate to this we* reviewed 174 websites and issued advice to 41 businesses resulting in many changes to websites.

Our response

- 2. We have decided to grant your request.
- 3. The Commission sent compliance advice letters to 37 businesses after reviewing terms and conditions of sale on 174 websites. We reviewed these terms for potentially misleading representations about consumers' rights that may breach section 13(i) of the Fair Trading Act 1986. The letters are contained in the box.com link provided with this letter and listed below.
- 4. We had identified 39 businesses to receive compliance advice, however the decision was made not to issue advice in two instances. The total of 41 referred to in the speech was an error.
- 5. We have redacted some names and contact details from the letters under section 9(2)(a) of the OIA to protect the privacy of natural persons.
- 6. We consider that good reasons exist for withholding these names and contact details and this is not outweighed by other considerations which would make it desirable, in the public interest, to make the information available (section 9(1) of the OIA).

- 7. If you are not satisfied with the Commission's response to your OIA request, section 28(3) of the OIA provides you with the right to ask an Ombudsman to investigate and review this response. However, we would welcome the opportunity to discuss any concerns with you first.
- 8. Please note the Commission will be publishing this response to your request on our website. Your personal details will be redacted from the published response.
